



# Former URANTIA Brotherhood to Be Known by New Name





These precipitous actions were apparently taken for several reasons, some of which were documented in letters from the trustees in recent months. There seem to be primarily three stated reasons for their action. First, in their view, criticism of URANTIA Foundation or any of its trustees constituted a violation of the Confirmatory Agreement and a possible "attack on the integrity of URANTIA Foundation." (The Executive Committee of URANTIA Brotherhood had sent a



critical letter to the Foundation shortly after three of five trustees resigned from URANTIA Foundation.) Second, the General Council of URANTIA Brotherhood unanimously passed a resolution affirming its independence as an autonomous democratic organization, apparently contravening the trustees' belief that URANTIA Brotherhood is an organization subservient to URANTIA Foundation. Third, the trustees had a concern about the activities and processes of URANTIA Brotherhood, which was expressed as "creeping churchification." The trustees have said that they will send their own full explanation to the readership. The General Council has not yet met to discuss its response to these actions.

## Executive Committee Met to Respond to Foundation's Action

A special meeting of the Executive Committee of the former URANTIA Brotherhood was held to respond to the three actions taken by URANTIA Foundation. At that meeting, the Executive Committee unanimously voted not to legally contest any of the actions taken by the Foundation. Members of the committee stated various reasons for their nonresistive vote. Among them was the view that terminating the affiliation constituted a "supreme opportunity to assume full responsibility for the

Brotherhood's founding purposes." The organization was originally founded as an independent, democratically organized religio-social organization committed to the dissemination of *The Urantia Book* and the fraternal association of believers. Several members also expressed the view that donor funds should not be used to wage a legal battle against URANTIA Foundation.

On a provisional basis, until a larger representative body can choose a name, a new name was given to the organization: Fifth Epochal Fellowship. It was also agreed to purchase a new head-quarters building, two blocks south of Diversey, into which the staff moved in mid-November. Even though the organization may not act any longer as the Foundation's agent for the sale of *The Urantia Book*, it will continue to undertake many of the other services previously offered.

David Elders, president of the newly named Fifth Epochal Fellowship, made these observations about the recent unprecedented events:

"There is significant irony in the situation we find ourselves in today. The phrase 'unity not uniformity' comes to mind. The wholly democratic, autonomous, social organization with a religious purpose clearly envisioned by our founders seems to represent the oppor-

tunity for this concept from The Urantia Book to actually function in a living way. That is, through the democratic process the unique material, mindal, and spiritual contributions of a worldwide and diverse readership would guarantee the forging of decisions based upon cultural diversity, tolerance, decentralization, and in keeping with the Jesusonian principles which would enable men and women to cooperate with each other in the spirit of unity. The autocratic and centralized control exercised by the four trustees of URANTIA Foundation using the licensed trademarks seems destined to insure only uniformity, perhaps at the expense of unity. Their claim that these marks, which The Urantia Book defines as symbolic of each mortal's citizenship in the higher universes under the Trinity Government of all Creation, cannot safely be used to identify a democratic organization (dedicated to the study and dissemination of the teachings) which is not subject to the direct control of URANTIA Foundation is, to me, extraordinary!

"The group decisions made by both the General Council and the Executive Committee over these last several months seem to be demonstrative of the power of group wisdom to navigate stormy waters and arrive at what I believe are conclusions which attempt to balance considerations of matter, mind,

and spirit by the decisions of diverse personalities. The living proof of 'unity not uniformity' was plain for me in the experience that the unanimity of our decisions to change our name and not contest the Foundation's actions was built on a broad diversity of viewpoints. Some of the trustees have characterized the Council's stated commitment to blend the values of spirit and the experience of personal religion into our organizational work as 'creeping churchification.' This somewhat negative characterization is the final irony, since it was a diverse group of unique individuals engaged in the democratic process who agreed unanimously that for us to be successful as an organization we must seek to blend the spiritual values from The Urantia Book into our work on its behalf."

### Special Advisory Meeting Held for Society Representatives

On November 1, 1989, URANTIA Foundation sent a letter to each URANTIA society stating that it terminated the Confirmatory Licensing Agreement with URANTIA Brotherhood. The letter also stated that a new organization was being constituted, with the name URANTIA Brotherhood Association which will apparently be vested with the sales agency function and will communicate with readers and groups who choose to affili-

ate with this new organization. The letter did not mention whether this new organization would have a democratically elected representative governing body.

In the trustees' letter of November 1, they stated the requirement that each society's "license from URANTIA Foundation requires that it be affiliated with URANTIA Foundation's licensee, which will be URANTIA Brotherhood Association. It does not permit affiliation with unlicensed organizations. Therefore, under the terms of the license, it is no longer permissible for [any] URANTIA society to affiliate with the organization which heretofore has been licensed to use the URANTIA Brotherhood name. It will be necessary for your organization to affiliate with URANTIA Brotherhood Association. Pending further information from URANTIA Foundation concerning URANTIA Brotherhood Association, the license provision concerning affiliation with URANTIA Brotherhood will be inoperative."

Because the Foundation letter stated that societies must choose between an affiliation with Fifth Epochal Fellowship or URANTIA Brotherhood Association, a special advisory meeting for society representatives was called to discuss the issues. Some 100 representatives met at Nordic Hills Resort in Itasca, IL, on November 18. Attendees included at least one representative from nearly each of the twenty societies chartered by the former URANTIA Brotherhood. Members of the General Council were also in attendance, as well as the Executive Committee who organized the meeting.

The advisory meeting began with short presentations by some members of the Executive Committee who expressed their viewpoints on issues related to the actions taken by the Foundation. This was followed by brief comments by former trustees Frank Sgaraglino, Helena Sprague and Gloriann Harris to explain and respond to questions about the conditions in the Foundation which led to their resignations in July. Also present was Bill Hales, a founding trustee and first president of the Foundation (for 23 years), who resigned as trustee emeritus in protest of the actions of the Foundation with regard to the Brotherhood. Bill voiced his encouragement for the Fellowship to fulfill its functions and his dismay over the Foundation's actions.

family participation, much effort has been given to providing child care and programs for youth at reasonable costs. Your REGISTRATION PACKET for the conference will be arriving in the mail in January.



## It's "Business as Usual" at New Headquarters



The central office of the renamed URANTIA Brotherhood is now fully operational at its new location in Chicago, a few blocks from the building in which it formerly shared space with URANTIA Foundation.

Staff members of the Fifth Epochal Fellowship moved on Thursday, November 16, 1989, into the building at 529 Wrightwood Avenue in the Lincoln Park area. All basic central services are being provided from this office, including communications with members and other readers of *The Urantia Book*, educational services, and organizational support of the governing bodies of the Fellowship and its constituent societies. Among the functions which will continue as before are reader referral, newsletter publishing, fundraising, conference planning and the Area Coordinator Program in support of study groups.

Staff members continuing to perform their jobs in the new office include Gloriann Harris, Director; Scott Forsythe, John Hales and Mike Painter, Assistant Directors; Matthew Block, administrative assistant; Marina Panos and Joanna Spina, clerical/secretarial support; and parttime bookkeeping staff. Computers, databases (including the mailing list), equipment, files and furniture were moved in a full day of activity, and the process of unpacking and settling in is well underway.

The search for new quarters took place shortly after URAN-TIA Foundation notified URANTIA Brotherhood of the termination of its lease at the Foundation's building at 533 Diversey. One objective was to remain, for a variety of reasons, in the Lincoln Park area—a centrally located neighborhood with a balance of residences, retail stores, restaurants and nonprofit

groups, as well as essential business services.

The building, which is currently leased with an option to buy, is a red-brick gabled Victorian with forest green trim. Previously a family residence, the building encompasses approximately 3,000 square feet in two stories plus basement. In move-in condition, it has many picturesque details including a marble fireplace, colored glass windows, a parquet floor in the dining room, sculptured and arched stairways, and carpeting throughout. Heating, air conditioning, electricity and plumbing are up to date. Its nine rooms (plus several baths) include a kitchen, dining room (which will be used as a meeting/conference room), and a number of other rooms which are being turned into offices, all making for a congenial, homelike working environment.

As in the past, the staff will communicate with readers by mail and phone and will extend a warm welcome to visitors who may be passing through town—provided, of course, that they call or come in during regular office hours (9 to 5 Monday-Friday), since there is no one in residence at the new headquarters. The phone number which URANTIA Brotherhood had for many years, 312-327-0424, has been retained, and the Fellowship now has a P.O. box at the nearby Lincoln Park branch in addition to the street address (see box). There is a direct number for the Fax machine (312-327-6159), which readers are also welcome to use in contacting headquarters. Commented Mike Painter, "We want to assure everyone that we remain in business. The Fellowship plans to continue virtually all the services it formerly provided—it's only changed its name."

## **History of Events...**

The following is a brief history of events starting in the 1950s which have contributed to the current series of actions taken by URANTIA Foundation and the former URANTIA Brotherhood.

1939—According to a 1958 memorandum by William S. Sadler, Jr., it was decided to invest the custodial responsibilities for The Urantia Book and the religio-social, democratic functions for its study and dissemination into separate organizations-URAN-TIA Foundation and URANTIA Brotherhood, respectively.

1950—URANTIA Foundation was established as a public, not-forprofit trust by five trustees via the Declaration of Trust. The objects of the trust were the promotion, improvement, and expansion among the peoples of the world of the comprehension and understanding of cosmology, as well as to perpetually preserve inviolate the text of The Urantia Book and to disseminate the principles, teachings and doctrines of The Urantia Book (see Declaration of Trust).

1952—The three concentric circles symbol was registered as a service mark by URANTIA Foundation. It began to be used by both URANTIA Foundation and URANTIA Brotherhood in 1950

and 1955, respectively.

1955—The constitution of URANTIA Brotherhood was adopted on January 2, 1955, by 36 founding members with the purpose of studying and disseminating the teachings of The Urantia Book, through the medium of fraternal association (see Constitution of URANTIA Brotherhood).

1955—URANTIA Brotherhood Corporation was established by the 14-member Executive Committee (who served as the corporation board of directors) in response to Chapter V of the By-Laws of URANTIA Brotherhood as a not-for-profit corporation in the State of Illinois, USA, on October 25, 1955. Brotherhood began distributing The Urantia Book.

1955 to 1960s—The newly formed religio-social organization called URANTIA Brotherhood was fairly small, with URANTIA Foundation, URANTIA Brotherhood and First URANTIA Society all comprised of many of the same individuals who functioned

out of 533 Diversey Parkway, Chicago, IL, USA.

1960s to 1970s—Growth in readership of The Urantia Book resulted in greater reader participation from outside the Chicago area and the chartering of more URANTIA societies. Increased interorganizational tension was a consequence of this growth.

1971 to 1972—URANTIA Foundation registered the three concentric circles and the word "URANTIA" as trademarks.

1974—Confirmatory Licensing Agreement with URANTIA Foundation was signed by URANTIA Brotherhood. This agreement formalized the terms of the Brotherhood's past use of the marks and set forth the structure for future use.

1974 to present—Each individual URANTIA society signed a "Licensing Agreement" which formally gave the societies the right to use the registered marks and governed each society's

use of the registered marks.

1975—Confirmatory Agency Agreement with URANTIA Foundation was signed by URANTIA Brotherhood Corporation to formalize its role as the Foundation's agent for the sale of The Urantia Book and other materials that the Foundation wished to sell. The word "URANTIAN" registered as a trademark.

1978—The word "URANTIA" and the concentric circles symbol

registered as collective membership marks.

1987—A proposal by the General Council for a test marketing study to be recommended to the Foundation resulted in the July 28, 1987, letter from the Foundation that stated that the license allowing the Brotherhood to use the marks and the Sales Agency Agreement would be revoked if the study was undertaken.

1987-1989—Extensive efforts by URANTIA Brotherhood president, Executive Committee and the General Council to work with the Foundation in the development and execution of projects and plans.

1988—The separate offices for URANTIA Brotherhood and URANTIA Foundation are reorganized as central office services with the intent of unifying the organizations' functional services

and improving efficiency.

February, 1989-Letter from URANTIA Brotherhood President David Elders to URANTIA Foundation President Martin Myers which summarized his feeling that Foundation methods to achieve its goals were not always consonant with those goals nor the spirit of the teachings of The Urantia Book. The Foundation president ended communication with the Brotherhood

June, 1989—Resignation of three of the five URANTIA Foundation trustees. Two of these trustees were responsible for the majority of ongoing communication between the two organizations.

July, 1989—The Executive Committee met in special session to discuss the resignation of the three trustees. A letter was sent from the Executive Committee to the Foundation stating their perceptions of the organizational behavior on the part of the Foundation president which was felt to be harmful and would no longer be accepted as a factor in the work of the Executive Committee.

September, 1989—The General Council met in special session (see page 3 of this issue of the Bulletin) to discuss the initiative of the Executive Committee and to determine further actions. The final resolutions resulting from this discussion were an affirmation of the actions of the Executive Committee, a redefinition of the relationship between the Brotherhood and Foundation which affirmed the existence of the Brotherhood as an independent, autonomous organization functioning on the basis of group wisdom and in keeping with the highest understanding of the teachings of The Urantia Book, to raise funds only for the Brotherhood, to re-establish a separate office services operation/staff, to request a lease with adequate space as well as signage, to effect a smooth working transition of office operations, to use the mailing list as the organization deemed appropriate, and to affirm the principles for which URANTIA Foundation was founded and the purposes that are shared with URANTIA Brotherhood.

October 30, 1989—URANTIA Foundation hand delivered three letters to URANTIA Brotherhood terminating the confirmatory sales agency agreement, confirmatory licensing agreement and

lease at 533 Diversey Parkway (see front page).

November 5, 1989—Special meeting of the Executive Committee (see front page) was held during which the committee voted not to legally contest the Foundation's actions, to instead change the name of the organization, and to move into a new head-

November 16, 1989-Fifth Epochal Fellowship (formerly URANTIA Brotherhood Corporation) offices moved to 529 Wrightwood Avenue, Chicago, Illinois (see special insert).

November 18, 1989—Prompted by a letter from URANTIA Foundation to the societies of the former URANTIA Brotherhood, a meeting with society representatives was held (see page 2).

Three past presidents of the Brotherhood also made some brief remarks. Meredith Sprunger said, speaking of the formation of the Fifth Epochal Fellowship, "This is a tremendous accomplishment, not only for the present, but also for the future." Paul Snider encouraged the group with his statement, "The organizational issues will fall into place as we go forward in faith, not fear, placing trust and confidence in each other." John Hales thanked the group for their encouragement and good will over the preceding weeks.

After the presentations, questions and comments were made by participants. The large group broke into smaller groups for further discussion and to formulate additional questions or statements regarding the current situation. Issues from these small groups which surfaced frequently included the kinds of programs and services the Fellowship will offer; the relationship with the Foundation and possibilities for reaffiliating; encouraging a sense of unity among the community of believers; communication between the former Brotherhood and readers; the role of societies in the Fellowship and/or URANTIA Brotherhood Association; and speculation about the Foundation's approach to carrying out its tasks.

After a great deal of discussion of these issues, the group ended the meeting by giving each other a hug and personally expressing their feelings to each other. As one participant said: "We cannot operate from fear. Some are afraid we are making a mistake. The group had to make a choice and has made a wise decision. I see the current situation as temporary-in five, ten, twenty or forty years it will all come back together. We need to correct things so that the same mistakes will not be made. We cannot affect what URANTIA Foundation does; we can only extend a welcoming hand if we are not subservient and not afraid."

The formal implications of the Foundation's actions with regard to societies were discussed in a memorandum to URANTIA society officers by Judicial Committee chairperson Steve Dreier:

"URANTIA Brotherhood has changed in name only. Our entire organizational structure remains intact. We are still an association of twenty societies and more than two hundred and fifty members-atlarge, approximately 1,200 members in all. The Constitution of the former URANTIA Brotherhood continues in effect as the Constitution of Fifth Epochal

Fellowship, and, as before, it is the procedural basis for our democratic group decisional activities. The members who have been elected by societies to serve on the General Council continue to function in those positions. The officers, Executive Committee members, and all nine departmental committees continue to carry out their constitutional responsibilities. Most services and actions will continue without substantial interruption.

"In addition, each society has its own local constitution and should continue to adhere to [its] requirements, including notification and majority vote requirements.

"Unfortunately, URANTIA Foundation has encouraged societies to ignore constitutional process. In selectively distributed written statements...the Trustees have claimed that their actions affect only 'the formal organization represented by the leadership of URANTIA Brotherhood at the national level.' In making this claim the Trustees are knowingly misrepresenting the basic structure of our organization and encouraging societies to disregard the requirements of both their local and international constitutions....There is no 'national level' apart from societies. The societies and their elected representatives are one body, one integrated organization."

Chairperson of the Charter Committee, Avi Dogim, detailed some of the difficulties inherent in the Foundation request:

"By terminating the Confirmatory Agreement with URANTIA Brotherhood, URANTIA Foundation insured that the former Brotherhood will be unable to use the three concentric circles symbol or the word 'URANTIA' as part of the organization's name without risking litigation. The Foundation can do the same to any URANTIA society. It should be clear, however, that the Foundation has no authority to revoke any society's charter. The charters have been issued by the Brotherhood and are valid even though URANTIA Brotherhood has had to change its name.

"Societies have been forced by the Foundation into making a choice. If they want to continue to use the marks, they must abandon the chartering organization with which they have been affiliated and join a new organization created by the Foundation for its own reasons. The other option societies have is to continue their affiliation with the former Brotherhood, provisionally named Fifth Epochal Fellowship. The latter choice would enable society members to maintain their involvement in a democratic process into which they have a great deal of input and over which they can exert influence. The former will relegate them to the status of subordinates who can be easily threatened with disaffiliation at the slightest provocation.

"When it comes down to it, the choice is between using the marks on our letterheads or acting in a way that upholds the values for which the marks stand. I hope that all societies will choose the latter. Regardless of each society's choice, however, I am certain that the present crisis presents a significant growth opportunity and that when the dust settles we will all be better off for it."

As of late December, 1989, nine of twenty societies have met and decided to maintain their affiliation with Fifth Epochal Fellowship. Oklahoma, New York, Seattle, Ontario, Alaska, Kansas City, Rocky Mountain, Glenview, and First Society are the societies which have thus far chosen to remain with the former URANTIA Brotherhood.

#### General Council Embarked on Redefined Course

Editor's note: The following report was written prior to the October 30, 1989 actions of URANTIA Foundation, at which time URANTIA Brotherhood Corporation was still the name of the organization.

The General Council held a special meeting on September 16–17, 1989, to discuss the impact on URANTIA Brother-

hood of the resignation of three of the five trustees of URANTIA Foundation in late June and early July. It was this meeting, and the resolutions passed, that apparently precipitated the Foundation's actions. During this meeting, a variety of topics were considered including perceptions of the current situation within URANTIA Foundation; the relationship between URANTIA Brotherhood and URANTIA Foundation; the role of URANTIA Brotherhood as a fellowship organization which encourages study and dissemination of the teachings of The Urantia Book; a letter sent to the Foundation by the Executive Committee of URANTIA Brotherhood detailing concerns with the situation in the Foundation; and an assessment of the kinds of values that were considered to be important for our organization in carrying out responsibilities associated with the fifth epochal revelation of truth on our planet.

Several resolutions emerged from the two-day meeting. One, which passed with the unanimous approval of the General Council, summarizes the direc-

tion set by this meeting:

"The recent culmination of events affecting the relationship between URANTIA Brotherhood and URANTIA Foundation has led the General Council to embark on a course of action which redefines that relationship. We therefore resolve to evaluate our organizational goals and plans and to institute such measures as to affirm our existence as an independent, autonomous organization, operating on the basis of group wisdom, and in keeping with our highest understanding of the teachings of *The Urantia Book*."

The General Council passed other resolutions which reflected the Brotherhood's desire to function independently and in keeping with high values. (See "VALUES" box for a list of

values which were specifically identified as important for our organization.) One resolution read: "Be it resolved that the fundraising function of URANTIA Brotherhood pertain only to the raising of funds for URANTIA Brotherhood. Previously the Finance Committee of URANTIA Brotherhood raised funds for both organizations. Because of differences in contributor accountability between the two organizations, the Council felt it financially prudent to raise funds for the Brotherhood only. It was also resolved that URANTIA Brotherhood would "...use its mailing list in any manner it deems appropriate." This decision reaffirmed the Council's commitment to move toward the achievement of the Brotherhood's purposes

#### What was that word?

LAW—The common use of the word would mean a rule established by authority, society, or custom. The word is used in this way in *The Urantia Book*. using its autonomous and duly constituted group process.

In light of the more independent direction set by the General Council at this meeting, it was deemed appropriate to again affirm that the General Council stands firmly behind the principles for which URANTIA Foundation was founded. The resolution read, "Be it resolved that the General Council of URANTIA Brotherhood affirms the principles for which URANTIA Foundation was founded and the purposes which we share in common, as stated in the Declaration of Trust."

Members of the Brotherhood were sent a report detailing the actions of the Executive Committee and General Council.
